**For successful completion and to avoid any awkward predicament which may arise during the election process, the Returning Officer announces the election schedule with emphasis on the following points, which are not in the constitution as it is, but shall be brought under strict consideration in pursuant to the rules directed by the constitution:**

- A. Nomination papers will be available from 16 September 2018 in every eligible member's ('A person must be a life member of AMWC for a minimum period of 2 years on the date of submission of nomination papers to be eligible to contest for any position in the executive committee effective from the AGM 2015') {Rule 16 Clause 6(a)} of AMWC constitution) valid email and can be collected from the undersigned Returning Officer (195 Longhurst Rd, Minto) by telephone on 0432 347 233 / 02 9603 6384.
- B. Nominee must be proposed and seconded by **two eligible (voter) members of the AMWC** and accompanied by the written **acknowledgment and willing comments on the candidacy** proposed.
- C. Please **print your name and address** on nomination paper and **sign with date**.
- D. One member cannot be nominee for more than one position and cannot nominate more than one candidate for the same position.
- E. Nomination paper must be received by the undersigned Returning Officer (195 Longhurst Rd, Minto) before 10.00 AM of 4 October 2018. In weekdays nomination can be submitted between 8.00 PM to 9.30 PM. **Postal submission will not be accepted.**
- F. Any delay/late submission of nomination paper shall not be accepted, incorrect name spelling, member number and unreadable handwriting on nomination paper shall not be accepted and chances of rejection are high due to strict scrutiny.
- G. Nomination paper can be withdrawn by 10:00 AM on 5 October 2018 (at least 48hrs before the start of AGM) by submitting written application by the candidate personally.
- H. Returning Officer will announce the final list of candidates by 10.00 AM on 6 October 2018 (24hrs before the start of AGM).
- I. Returning Officer's decision will be the final verdict on any dispute, conflict, contradiction and issues on the election business which is not specially or clearly directed in the constitution to avoid any serious dilemma on the issues.
